

M^SO

Methylated Seed Oil Surfactant / Penetrant



GENERAL INFORMATION

M^SO is derived from fatty acids extracted from soybean oil. Methylated oils are low viscosity fluids which have low volatility and good solvent properties. These characteristics enable these oils to coat leaf surfaces, soften and penetrate the waxy leaf cuticles. Thus, pesticide activity is enhanced when used with products calling for an oil-based adjuvant.

COMPATIBILITY

M^SO is designed to be used with post emergence herbicides, however, a simple jar test should be conducted before any large scale mixing. Always refer to the pesticide label for recommendations & precautions.

DIRECTIONS

Use in strict accordance with pesticide label cautions, warnings and other directions. Apply 1 to 2 pints of **M^SO** per acre or as prescribed by the tank mix partner's label. Use the higher rate on hard to control weeds or weeds under stress. Include liquid fertilizer (UAN) or ammonium sulfate at rate specified on the pesticide label.

Preparation and Application:

While agitating, fill tank half full with water, add proper amount of herbicide, then **M^SO**. Continue to agitate while adding balance of water to tank. Frequent agitation will assure even distribution of spray mix. Where possible, position spray nozzle to direct spray toward weeds and away from plants. Use in strict accordance with pesticide label cautions, warnings and directions. **M^SO** should not be used with any product whose label recommends against the use of an adjuvant. Keep this container tightly closed and DO NOT allow water to be introduced into it.

FIRST AID
