### GENERAL INFORMATION

MarKey® Boron 10% solution is a manufactured liquid nutrient. Its use is suggested as a supplement to a regular balanced fertilizer program to enhance yields and improve quality.

### DIRECTIONS FOR USE

#### MIXING DIRECTIONS

Fill spray tank 1/3 to 1/2 with water. With agitator running, add MarKey® Boron 10% solution. Agitate while adding remaining water and any other fertilizer. Add pesticide last and continue to agitate. Agitate well prior to spraying if mix has been left standing for a short time.

#### GROUND APPLICATIONS

MarKey® Boron 10% solution should not exceed 1 pint per gallon of water. Do not exceed 3/4 gallon of MarKey® Boron 10% per acre. Apply the recommended amount of MarKey® Boron 10% with sufficient water to provide the desired coverage. When less than 10 gallons of water per acre is used, a slight burning of foliage may occur.

#### AERIAL APPLICATIONS

Using a total of 7 to 10 gallons of water per acre is sufficient to apply the recommended amount of MarKey® Boron 10% solution. If less water is used, a slight burning of the foliage may occur. Aerial application should not exceed 1 quart per gallon of water to insure good coverage.

**WARNING:** Use of MarKey® Boron 10% solution on any crops other than those recommended may result in serious injury to the crop(s). Do not use MarKey® Boron 10% solution with oils, limesulfur and/or highly alkaline spray materials.

#### STORAGE AND DISPOSAL

This product must be stored above 40°F. Be careful not to contaminate water, food, or feed by disposal or storage. All containers should be offered for reconditioning or recycling.
