It can be applied to the following crops: Vegetables, fruit, row crops, grain crops, deciduous fruit and nut trees. MarKey® R-CZ 44 is compatible with most herbicides, insecticides and agricultural chemicals that can be utilized in combination with other liquid and water soluble fertilizers. MarKey® R-CZ 44 may not be compatible with all liquid fertilizer formulations. Please consult your Mar Vista Representative for specific placement and application guidelines.

NOTE: MarKey® R-CZ 44 cannot be used with liquid fertilizers which contain orthophosphates. DO NOT MIX WITH CATIONIC PESTICIDES.
