SOIL APPLICATION

This product may be applied but not limited to cane and vine crops, citrus crops, nut crops, stone and pome fruit crops.

Annual Crops: Apply 2-5 gallons per acre. Application should be done in the transplant water or through irrigation at time of planting. During season, apply 5-20 gallons per acre. Applications should begin 2-4 weeks after emergence or transplant establishment. Repeat every 3-4 weeks throughout the critical development stages (flowering, fruit set, and sizing period).

Perennial Crops: Fall: Apply 10-20 gallons per acre through irrigation system. Apply while roots are still growing. In-season: Apply 10-20 gallons per acre during the initial root flush period. Repeat monthly at a rate of 5-20 gallons per acre throughout the critical development stages.
