GENERAL INFORMATION

Mar Vista 3-2-18 has been designed for soil applications and will prevent or correct nutrient deficiencies in a wide range of agronomic and ornamental plants. Its use is suggested as a supplement to a regular, balanced fertilizer program to enhance yields and improve quality.

DIRECTIONS FOR USE

TRANSPLANT: Apply 3 to 5 gallons per acre with a minimum of 100 gallons of water per acre. Do NOT exceed 3% solution of Mar Vista 3-2-18 to water.

STARTER/PRE-PLANT: Shank or band 1 to 3 inches directly below seed line at 3 to 10 gallons per acre or offset at 10 to 30 gallons per acre prior to planting.

IN-SEASON: Apply 10 to 20 gallons per acre in irrigation water or as side dress application.

DRIP/ MICRO SPRINKLER: Inject product 5 to 20 gallons per acre per irrigation. Follow application with at least 2 hours of continuous irrigation. Inject Mar Vista 3-2-18 into systems after filters as fast as your system will allow.

NOTE: It is highly recommended to follow all soil applications of Mar Vista 3-2-18 with an irrigation within 24 hours of application.

Recommended to check compatibility with other products with jar test before mixing. Do NOT mix with calcium fertilizers.
