GENERAL INFORMATION

When used as suggested, Root-Active helps root development, plant growth due to the surface activity of Quillaja and Yucca extracts which improve water activity in the soil by increasing water penetration and retention.

DIRECTIONS FOR USE

Soil: Amendment applied through drip irrigation or sprinkler irrigation.

For Hard compacted soils: Mix with irrigation water at a rate of 3 gallons/acre preferably at or before root flush.

For normal soils: Mix with irrigation water at a rate of 8 to 32 ounces per acre once every 7 days as needed.

For use with seeds: Apply at 1 to 2 ounces per acre in the seed furrow at time of sowing to help water penetration of seed.

STORAGE AND DISPOSAL

Storage: Store in original container away from children, animals, foods, feeds and seeds. Keep away from direct sunlight and heat sources.

Product Disposal: Wastes resulting from use of this product may be disposed of on site or at an approved waste disposal facility.
