DIRECTIONS FOR USE

Soil: For normal soils use 16 oz. per acre with irrigation water. For compacted soils or for water penetration problems, use 32 oz. per acre, on first application. Repeat application at 16 oz. per acre rate if necessary.

Row Crops: Can be metered into first irrigation water or mixed with starter or side dress fertilizer.

Trees and Vines: Dilute in sufficient water for coverage and meter into first irrigation water through drip irrigation system or spray soil surface to be irrigated if drip irrigation is not used.

Transplants: Mix with transplant water to apply one 16 oz. per acre.

Plants: Use four fluid ounces per 100 gallons of water to reduce surface tension and improve wetting in agricultural sprays. If foaming is a problem, use an anti-foam agent in the spray formulation or fertilizer solution.

STORAGE AND DISPOSAL

Environmental Hazards: Do not contaminate water, food, or feed by storage or disposal.

Storage: Store in original container away from children, animals, foods, feeds and seeds. Keep away from direct sunlight and heat sources. In the event of spillage or leakage, soak up the material with absorbent clay, sand, sawdust or other absorbent material. Scrape up and dispose in accordance with Product Disposal.
