General Information

GreenFurrow Humic Acid 12% may be applied to most crops. GreenFurrow Humic Acid is readily dispersed in most fertilizer or micronutrient products. Avoid using this product with acids and oxidizers. This product may be applied through various irrigation water systems.

This product is a weak alkaline solution and could alter the pH of certain solutions. A weak acid may be used to reduce the pH of the spray solution.

DIRECTIONS FOR USE

FOLIAR APPLICATIONS

Apply 1-3 quarts per acre with sufficient water for best coverage. This product can be aerial or ground applied. This product is a weak alkaline salt and may be neutralized with a buffer. High rates of this product in combinations with high rate of other materials may cause burn.

SOIL APPLICATIONS

Apply 1-12 quarts per acre with fertilizer or water. This product may require agitation when mixed in concentrated phosphate fertilizer such as 10-34-0. For best compatibility results follow this sequence of mixing:

1. Water
2. Humic Acid
3. Fertilizer
