GreenFurrow Organics Nutri-Drive is for use in all crops except ornamentals and greenhouse crops in combination with water-soluble nutritional products. Crops included are vegetables, table crops, row crops, field crops, feed crops, trees, vines, and all horticultural crops. Can be applied on all soil types and pH ranges, dips and watering and all transplant solutions. This product will assist in combination with your fertilizers to achieve more efficient results.

### DIRECTIONS OF USE

GreenFurrow Organics Nutri-Drive is compatible with most liquid fertilizers including organic nutrients. The inclusion rate is 4-8 oz. per acre of applied fertilizer. Foliar applications should use the lower (4 oz. ) rate. Soil application in combination with fertilizers may be more effective at the higher (8 oz. ) rate. Perform a jar test to ensure compatibility.

### COMPATIBILITY

Use in accordance with recommendations of qualified individual or institution such as, but not limited to, a certain crop advisor, agronomist, university crop extension publication, or apply according to recommendations in your approved nutrient management plan. When tank mixing other products, "Jar Test" proportionally mixed components to confirm compatibility. When blending with other products, trial blends should be conducted before beginning large scale mixing. When blending with other pesticides and fertilizers, the sequence should be as follow: water, pesticide, fertilizer, micro-nutrients.

### STORAGE AND DISPOSAL

Store in original container only and keep sealed. Store in closed storage areas. Use caution when moving, opening, closing and pouring.
