## GENERAL INFORMATION

GreenFurrow Organics 0-0-3 Seaweed Extract may increase vigor in growing plants. **Storage:** Store this product in a clean, dry area. Keep temperatures between freezing and 110 °F. Once diluted, do not store for more than 24 hours. If mixed with an agricultural chemical, use product immediately. Do not store this product in direct sunlight and keep container closed when not in use. **Compatibility:** GreenFurrow Organics 0-0-3 Seaweed Extract is compatible with water and liquid fertilizers. While this product can be mixed with most agricultural chemicals, it is recommended that compatibility should be checked prior to mixing. Do not mix GreenFurrow Organics 0-0-3 Seaweed Extract with Calcium products. Do not mix with emulsifiable concentrate pesticides. Use in accordance with recommendations of qualified individual or institution such as, but not limited to, a certain crop advisor, agronomist, university crop extension publication, or apply according to recommendations in your approved nutrient management plan. When tank mixing other products, "Jar Test" proportionally mixed components to confirm compatibility. When blending with other products, trial blends should be conducted before beginning large scale mixing. When blending with other pesticides and fertilizers, the sequence should be as follow: water, pesticide, fertilizer, micro-nutrients.

## DIRECTIONS FOR USE

**Recommended application equipment:** Fertigation equipment, or foliar application spray equipment. Shake or agitate this product prior to use. This product should not be applied unless it is diluted. Dilute desired amount of GreenFurrow Organics 0-0-3 Seaweed Extract in a minimum of 50 parts water as a premix for injection or foliar application. This product may be reapplied three times during growing seasons but it is recommended that you consult a crop consultant for specific timing.

### FOLIAR APPLICATION RATES:

Apply 2-4 quarts per acre per application.

### FERTIGATION APPLICATION RATES:

**Drip irrigation:** Apply 2-4 quarts per acre per application.

**Micro-sprinklers:** Apply 2-4 quarts per acre per application.

**Water-run(flood):** Apply 2-4 quarts per acre per application.
